## **PAYMENT, RESIGNATION AND TERMINATION POLICIES**

Each member application is subject to review by the Board of Directors of New Bern Golf and Country Club. Approval of a member application is at the discretion of the Board of Directors of New Bern Golf and Country Club. All applicants agree to a three (3) year continuous active membership and shall pay all applicable dues, fees, dining minimums, capital fund fees, and assessments during the three (3) year period. In the event a membership is resigned or terminated during such three (3) year period, all applicable dues, fees, dining minimums, capital fund fees, and assessments which would accrue during the remaining term of such period shall be immediately due and payable by the member.

- Members must submit written notice (via hand, mail or e-mail delivery) to resign their membership. Resignation becomes effective the last of the month in which the resignation is received by NBG&CC.
- Members who own stock must return their stock to NBG&CC upon resignation. NBG&CC will purchase the stock for the exact amount the resigning member paid for the stock.
- A married applicant's spouse shall be jointly and severally liable with the applicant for all amounts incurred under or by virtue of the applicant's membership.

- End of month statements are due on or before the 15th of the following month. If a member fails to pay in full by the 15th, a \$50 penalty will be added to their account. Membership and Club privileges will be suspended if an account becomes 60-days past due.
